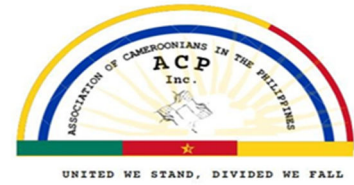

DECREE No.01/ PR ACPINC/2025 On the organization of the death management program within the Cameroonian community residing in the Philippines

THE PRESIDENT OF THE ASSOCIATION OF CAMEROONIANS IN THE PHILIPPINES,

Given the Statutes of the Association of Cameroonians in the Philippines;

Given the Internal Rules and Regulations of the Association;

Given the resolutions of the General Assembly;

Given service requirements,

HEREBY DECREES:

## CHAPTER I: GENERAL PROVISIONS

Article 1.- This decree establishes the implementing procedures for the death management program within the Cameroonian community residing in the Philippines.

Article 2.- The program aims to:

- Ensure adequate assistance for death management;
- Guarantee the repatriation of bodies to Cameroon;
- Provide financial support to bereaved families.

## CHAPTER II: FINANCIAL CONTRIBUTIONS

Article 3.- (1) In the event of a member's death, contribution is mandatory and set at 1000 pesos per member.

(2) For the following cases of death, contribution is optional:

- Death of a spouse: 500 pesos per member
- Death of a child: 500 pesos per member

(3) The payment deadline is set at two weeks after the official opening of the contribution register.

## CHAPTER III: SUPPORT PROCEDURE

Article 4.- The application procedure includes:

1. Notification to the Executive Bureau
2. Official request for support
3. Information verification
4. Approval by competent authorities

Article 5.- (1) A special account shall be opened for managing collected funds. (2) A detailed register of contributions and expenses shall be maintained.

#### CHAPTER IV: SANCTIONS

Article 6.- Failure to comply with the mandatory contribution in case of a member's death shall be sanctioned as follows:

1. First breach: Written warning
2. Second breach: Temporary suspension
3. Third breach: Permanent exclusion

Article 7.- No sanctions shall apply for non-contribution in cases of death of a spouse or child.

#### CHAPTER V: FINAL PROVISIONS

Article 8.- Practical modalities for implementing this decree shall be specified by Executive Bureau memorandum.

Article 9.- This decree shall be registered, published and communicated wherever necessary.
